


I am sending this notarized letter to document me and my sibling's interest in this matter.

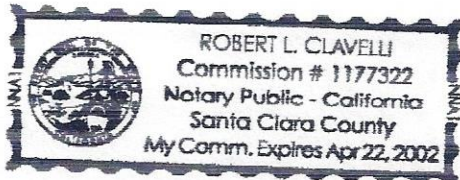
